"Neurodevelopmental Outcomes of Infants and Children Prenatally Opioid-Exposed"

Kerry Proctor-Williams is a Professor of Speech-Language Pathology at East Tennessee State University. She received her PhD from the University of Kansas after working clinically for many years. Research interests include the feeding, speech, language, and literacy outcomes of prenatally drug-exposed infants and children, child language acquisition and disorders, and interprofessional education.

<u>Abstract:</u> The growth of the population of infants and children prenatally exposed to opioids directly impacts speech-language pathology (SLP) caseloads. This presentation begins with background information about the the opioid crisis, incidence of NAS, its assessment and treatment in the NICU, and evidence-based information about neurodevelopmental outcomes for children post-NAS.


