- ✓ Scroll to ZSL_Gift_Balances Endowed and Gift Restricted Balances to begin.



Column	Description
FY	The accounting year in which the balance is being reported. The UT Fiscal year begins in July and ends in June.
Period	Unit that subdivides a fiscal year. UT's fiscal year begins in July and ends in June. July is period 01, August 02, and so on
BE	A 3-digit code that indicates the campus to which a fund belongs. This code consists of the number 7 plus the campus code value.
Budget Entity	Organizational unit in the hierarchical structure of the university that corresponds to the campus to which the fund belongs.
Coll	A 5-digit code that indicates the college or division the endowment belongs to. This code consists of the Budget Entity Code plus 2 subsequent digits that identify the college/division.
Dept.	An 8-digit code that indicates the university department which the endowment belongs to. This code consists of the 5-digit Reporting College/Division code plus 3 subsequent digits that identify the department
Department	Organizational unit in the hierarchical structure of the university to which cost centers and WBS elements are assigned.
Func	A 4-digit code that indicates the functional area to which a fund belongs.
Functional Area	An accounting unit that classifies expenses by function.
Fund Center	A code of up to 10 digits that identifies a particular collection of funds (cost centers and/or WBS elements).
Funds Center Name	The descriptive title for a funds center.

UTF Gift Fund	The "S" fund number with a 2 in the 6th position for a UTF gift fund that is related to a UT restricted gift fund.
UTF Gift Fund Name	The descriptive name for the UTF gift fund.
FY Beginning Balance Composite	The combined balance of the UT restricted gift fund and the related UTF gift fund at the beginning of the selected fiscal year
FYTD Add'l Gifts	Sum of gifts received in the UTF gift fund during the selected fiscal year.
FYTD Endowment Income	Sum of endowment distributions credited to the UT restricted gift fund for the selected fiscal year.
FYTD Net Transfers	The combined sum of gift transfers: • between UT restricted gift funds and UTF gift funds, • between UT restricted gift funds only, or • between UT restricted gift funds and endowments. Monthly entries to fund UT restricted gift deficits from their related UTF gift fund will result in a net transfer of zero because the balances are combined.
