### **Federal Loan Exit Counseling**

#### StudentLoans.gov

Students who have <u>accepted federal</u> <u>loans</u>, and applied the funds toward the

cost of tuition, are required by federal law to complete loan exit counseling prior to their graduation. An exit interview is a loan counseling session in which students are advised regarding their loan repayment schedule, obligations, and rights to deferment and/or cancellation. **Beginning March1** through May 6, 2016, students can complete this requirement online at www.studentloans.gov. If you prefer a one on one session, please contact the Literacy Coordinator at 901-448-7703.

Only students who have ACCEPTED Federal Student Loans, and applied the funds toward the cost of tuition, you are required to have loan exit counseling before you graduate.

### **Perkins Loan Exit Counseling**

Loans made through the Federal Perkins Loan Program, often called Perkins Loans, are low-interest federal student loans for undergraduate and graduate. Perkins Loans exit counseling is required by federal law before you graduate.

### Free Application for Federal Student Aid (FAFSA) 2016-17

**REMINDER:** The Free Application for Federal Student Aid (**FAFSA**) is due **March 15, 2016**.

The FAFSA is required for consideration of federal loans and financial need based scholarships for the 2016-2017 academic year (fall term 2016, spring term 2017, and summer term 2017). You can complete your FAFSA at www.fafsa.ed.gov.

The Federal Government has launched the IRS Data Retrieval Tool which allows you to transfer your tax information directly from the IRS into your FAFSA, making the form easier than ever to complete.

### **One On One Counseling**

Students who do not complete the required One-One Financial Aid Sessions by Friday, **April 1, 2016** will receive a "<u>registration hold</u>," and will not be allowed to register until the counseling is completed.

HCPC Compliance Package of the Year - Student Competition 2015 - The HCPC's Compliance Package of the Year competition has recognized the most innovative pharmaceutical packages designed to improve patient adherence since 1995. In 2015, the organization's 25th anniversary, the HCPC is launching a corresponding student competition to recognize innovative pharmaceutical packaging designs from undergraduate or graduate students of pharmaceutical and/or packaging schools that assists patients in taking their medication as prescribed. The highest scoring entry will be named as HCPC Compliance Package of the Year Student Winner and will receive award(s) at the Rx Adherence conference. The next two highest scores will receive HCPC Compliance Package of the Year Certificates of Merit. The winning entry will receive a \$1,000 scholarship and the second place winning entry will receive \$500.

Note: Students may only receive this award one time. **Materials must be postmarked by March 15, 2016.**
