Highlights June 21 Meeting

Jerry Hall, Director of UTHSC Human Resources, discussed retirement and benefits. Mr. Hall spoke briefly about his history with the Human Resources Department since he began working at UT. There are fifteen employees now in Human Resources; twelve of these employees are working toward their Masters Degrees. A website has been developed for Human Resources, and Mr. Hall emphasized that this resource will not take away from one on one interaction with employees.

The Department offers a Retirement 101 Class for those who are planning to retire; this class is held quarterly. The Life Planning Retirement Seminar is held every fall. TIAA-CREF representatives and other retirement agency representatives come to the campus for quarterly meetings with those who desire assistance.

Mr. Hall emphasized that retirement and investment opportunities are available for all new employees. Information about these areas is often published in the UT Record and in Human Resources newsletters.

In answering questions from retirees, Mr. Hall made the following comments:

- 1. A table with representatives from the UTHSC Retirees Association may be set up at the Fall Retirement Seminar.
- 2. A brochure regarding retirement benefits will be developed and given to new retirees in addition to information about the website.
- 3. It was mentioned that we would like for new retirees to know that the Retirees Association exists. New retirees are often unaware of their benefits. A four-page brochure is used in Knoxville for those retirees; we may have one developed that is similar to this one. Retirees can still use state discounts when traveling.
- 4. Life planning seminars are open to all employees and retirees. These seminars include information on financial planning, wills, and estates. Social Security representatives also come to campus and hold workshops. The next life-planning seminar is scheduled for August.
- 5. Knoxville has a room for retirees that is manned by retired volunteers where those considering retirement can come for information.
- 6. There is a need for a campus listserv with lists of events that retirees are eligible to attend.
