#### Dear UTHSC Investigators,

This note is to bring you up to date regarding the Postdoc Office's attention to expected changes to federal regulations that may affect your research budgets. As you may have heard, there are proposed revisions to the Fair Labor Standards Act (FLSA) regulations that would change the "white collar" exemption rules. One proposed change is an increase in the salary threshold to \$50,440, or greater, to qualify as exempt from overtime pay. Our postdoctoral fellows are currently classified as "exempt" employees under the learned professional exemption. If this salary threshold proposal goes into effect, at current salary levels, many of our postdoctoral fellows would no longer qualify as exempt employees and would be entitled to overtime pay for each hour worked over 40 in a work week. An increase in the post-doctoral stipend to reach the threshold, or a limitation of work hours, would have an immediate negative impact on your research budget and the entire UTHSC research enterprise, as well as the training goals of the postdoctoral research fellowship program.

A number of organizations have filed comments opposing the FLSA changes, but whether the proposed regulation is amended, or an exemption for postdoctoral fellows is granted, is uncertain. The proposed FLSA changes may go into effect as early as the second quarter of FY'17 (Fall 2016). For this reason, the Postdoc Office, the Vice Chancellor for Research, the Human Resources Office, the Vice Chancellor for Academic, Faculty, and Student Affairs, and the General Counsel's Office have been exploring options to provide adequate preparation and solutions. We will continue to keep you informed as this situation progresses.

On September 30, 2016, Dr. XX's current appointment as a Postdoctoral Fellow will expire. UTHSC College of Graduate Health Sciences Policy states that a fellow may not exceed five years postdoctoral training at UTHSC, and may not exceed eight years training in total.

Extensions must be approved by the Associate Dean for Postdoctoral Affairs.
